

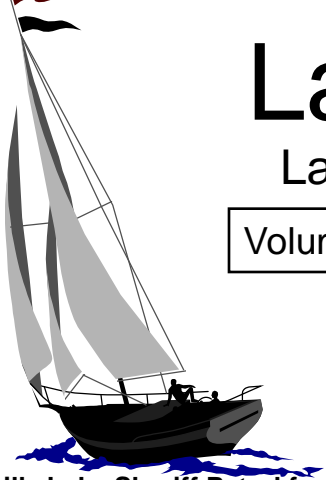

Lakeville Lake Sheriff Patrol for 2010

In November 2009 the LLPOA Board notified property owners that budget cuts in the Oakland County Sheriff's Office would result in the elimination of Sheriff patrols for Lakeville lake in 2010. The Marine Sheriff had representatives at the November 24, 2009 LLPOA meeting to discuss the situation with the property owners.

The meeting lead to two developments that changed the patrol situation for 2010. Addison Township received an unexpected reimbursement from the Oakland County Sheriff's Office for officer's court time. Township Supervisor Bruce Pearson agreed to apply the money to fund Marine Sheriff patrols for 2010. The hours of patrol will be reduced from 2009 levels, but should cover weekends and Holidays. Additionally, Bruce Pearson negotiated with the Marine Sheriff to allow the regular Sheriff to use the Sheriff's boat when they had available time in their normal duties.

The result is some level of Sheriff patrol coverage for Lakeville Lake for this summer. If there is a need for assistance during times when the Marine patrol is not on duty, the Oakland County Sheriff will respond to calls to their normal dispatcher.

Septic System Discussion

The Oakland County Supervisor of Environmental Health Services is scheduled to attend the June 22, 2010 LLPOA meeting to discuss septic system issues with the residents. There will be an opportunity to ask questions.

DNR Fish Trapping on Lakeville Lake

A number of residents noticed buoys in front of their property during the third week of May and wondered what they were. We discovered that the DNR was conducting a survey of the fish population in Lakeville Lake and had set fish traps in different areas of the lake. The DNR periodically surveys the lakes to determine the varieties and size of fish present. The resulting information is then used in planning for their fish stocking program. A healthy fish population is one of the indicators of a healthy lake environment.

Weed Control Activities for 2010

Our engineering consultant identified about 30 acres of invasive weed species in Lakeville Lake this spring and recommended targeted herbicide treatment. There were about 25 acres of Eurasian Milfoil and five acres of Starry Stonewort. Neither of the weeds are native to Herbicide treatment was applied June 1, 2010.

The weed harvester has been placed in service for our normal weed cutting activity and has been operating for the last three weeks. The cutting will continue through the summer as in the past. At this point one harvester is being operated. A second harvester is available if the weed volume is beyond the capacity of the harvester in operation.
