

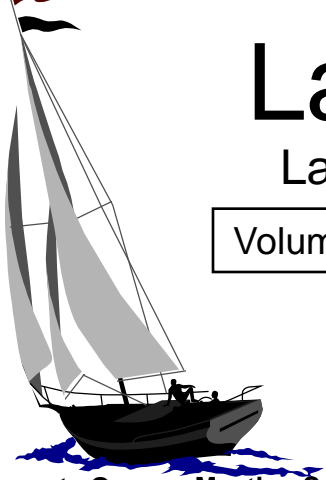

New Property Owners Meeting Schedule

The LLPOA Board has changed the Regular Meeting schedule for the LLPOA beginning in 2011. Regular Meetings are now scheduled for the fourth Tuesday of each **even** numbered month (except December). The Regular Meetings had previously been scheduled for the odd numbered months with the Annual Meeting occurring in June.

The new meeting schedule provides for a better alignment of activities between the Lakeville Lake Property Owners Association, the Lake Restoration Association and the Lake Improvement Board.

The June meeting will continue to be the Annual Meeting where Board elections are held. Special Meetings will be scheduled when necessary with notice provided to the property owners.

Special Meeting Scheduled for January 25, 2011

There is a Special Meeting of the Lakeville Lake Property Owners Association scheduled for January 25, 2011 at 7:30 p.m. at the Addison Township Complex.

Representatives from Progressive AE, our engineering consultant on weed control, and the Michigan Department of Environmental Quality will discuss weed habitat in Lakeville Lake and potential future weed management actions.

The herbicide treatments initiated in 2006 have effectively reduced the invasive Eurasian Milfoil species but a new invasive weed, Starry Stonewort is spreading significantly in areas of the lake. Like Eurasian Milfoil, Starry Stonewort is not easily controlled by mechanical harvesting.

Fish Stocking

Last fall the LLPOA arranged to stock Walleye in Lakeville Lake. The stocked fish ranged from seven to 14 inches in length.

Walleye are not expected to reproduce in our lake based on the lake's bottom composition but the stocked fish are expected to live out their normal life cycle.

Marine Sheriff Patrol for 2011

The Oakland County Marine Sheriff notified Addison Township that there will be **no patrols** scheduled for Lakeville Lake this year due to budget cuts.

We had the same situation last year before Addison Township received an unexpected reimbursement from the Oakland County Sheriff and used it to fund a reduced level of Marine Patrols for 2010. The Township does not anticipate being able to fund any Marine Patrols for 2011. The Oakland County Sheriff will continue to respond to calls related to lake issues through their normal dispatcher.

The notice will be discussed at the January 25, 2011 Special Meeting. Property owner suggestions will be welcomed.

LLPOA Board Officer Changes

LLPOA Board officer appointments for 2010-2011 were made at the July LLPOA meeting.

Gerald Galea replaced Paul Woodring as President, Chuck Sargent replaced Gene Crombez as Vice President and Gene Crombez assumed the Treasurer responsibilities from Gerald Galea. Jeff Banaszynski retained the Secretary position.

Our thanks go out to Paul Woodring for his service as LLPOA President from 2005 through 2010. Paul continues to serve as a Director.
